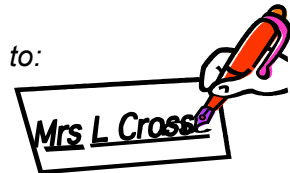

BOOKING TERMS AND CONDITIONS

BOOKING

- a) A security deposit is payable to cover any breakages or damage to the villa during your stay. This deposit of £150 is added to the total fee.
- b) The security deposit will be repaid in full upon your return home following inspection of the property at the end of the stay. However, if any damage to the property is found, or breakages in the furnishings discovered, the deposit will be repaid less the costs of making good the situation. Excessive cleaning requirements at the end of a stay will also lead to a deduction being made from the deposit.
- c) The villa cannot be let to a person under 18 years of age.
- d) You must not sub-let the accommodation, allow persons not listed on the booking form to stay overnight without letting us know or allow pets or animals to stay in the villa.
- e) No smoking is permitted inside the villa.
- f) Please note that for safety reasons children should not be left unattended in the pool area.
- g) Any specific conditions of stay displayed in the villa will apply for the duration of your stay.

LIABILITY

- a) We cannot accept any liability whatsoever for:
 - any injury sustained by you or any other visitor either in the villa or swimming pool
 - any loss or damage, however caused, to any property brought onto the premises.
- b) Please note you are liable for any damage to the villa or its contents during your booked dates.
- c) Without any restriction to the foregoing, we shall not be liable for any loss or damage arising in connection with your stay.

CANCELLATION

- a) The booking deposit is non-refundable.
- b) You may cancel the booking in writing at any time prior to your arrival date. The date of cancellation will be taken as the date of the postmark of the letter. In the event of cancellation, the cancellation fees shown in the table below will apply.
- c) If, after cancellation, the villa is re-booked, then all cancellation fees will be refunded (less the original deposit).
